The composition of the Nomination and Remuneration Committee set forth above becomes valid since being determined until the closing of 2027 Annual General Meeting of Shareholders, unless there is a member resignation, or no longer working for the Company, or when the Board of Commissioners decides to change the composition of the Nomination and Remuneration Committee (whichever comes earlier).
